Safety First – 7 guidelines


How visible and active are you already involved in strengthening our health & safety culture? Do you report unsafe behaviour? And do you give feedback to your colleagues in case you see behaviour that is not in line? An overview of the guidelines.

1. Our common responsibility

- A healthy & safe working environment starts with you.
- Always act safely and actively contribute to a safe workplace.

2. Take safety measures seriously

- Follow all safety instructions and procedures.
- Always wear the correct personal protective equipment (PPE).
- Stay alert and spot hazards in your work environment.



3. Report incidents

- Report every incident, near miss and unsafe situation immediately via [our Health & Safety Point](#).
- Follow the on-site emergency procedures in case of fire, leaks or accidents.
- Be familiar with evacuation routes and procedures as published on Tengio.

4. Keep learning, keep improving

- Take part in mandatory Behaviour Based Safety training.
- Attend the safety trainings associated with your position (a.o. responsible driver training & cyber security training).
- Use the digital [Driver Manual](#) as the source document for all operational task instructions.

5. Keep equipment and devices safe and reliable

- Carry out inspections and maintenance on time and report issues immediately to your manager and the department concerned.
- Take immediate action in case of breakdowns or unsafe situations.
- Comply with cyber security rules and attend prescribed training courses.
- Share experiences and tips during toolbox meetings.

6. Contribute to a healthy and safe work environment

- Follow the Company Specific Arrangements and other related regulations of Van den Bosch.
- Adhere to the [Code of Conduct](#) as well and help build a respectful workplace.

7. Walk the talk

- Set a good example, share your feedback and suggest improvements.
- Encourage safe behaviour and speak up when something is not in line.
- Cooperate in audits, spot checks and safety walks & talks.
- See every report as an opportunity to improve.
